## 2. HAZARDS IDENTIFICATION

### **Hazard classification**

Harmful if inhaled: Category 4

### **Other Hazards**

The thermal decomposition vapors of fluorinated polymers may cause polymer fume fever with flu-like symptoms in humans, especially when smoking contaminated tobacco. Repeated episodes of polymer fume fever may result in persistent lung effects. Vapors are heavier than air and can cause suffocation by reducing oxygen available for breathing. Prolong skin contact may cause dermatitis or frostbite. Misuse or intentional inhalation abuse may lead to death without warning symptoms, due to cardiac effects.

### **4. FIRST AID MEASURES**

**Inhalation:** Remove patient to fresh air. If not breathing, give artificial respiration. Give oxygen as necessary, if a qualified person is available. Get medical attention if necessary.

**Eye:** Flush with a large amount of water for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue to rinse. Get medical attention if necessary.

**Skin:** Wash with water for at least 15 minutes. Remove contaminated clothing. Wash contaminated clothing before reuse. Get medical attention if necessary.

## 6. ACCIDENTAL RELEASE MEASURES

Evacuate personnel, ventilate area with fresh air, if a large amount is accidentally released, use self-contained breathing apparatus. Dike spill. Prevent material from entering sewers, waterways or low areas. Soak up with sand, earth, vermiculite or other non-combustible absorbent materials.

## 7. HANDLING AND STORAGE

**Handling:** Use in a well-ventilated area to avoid breathing vapors. Vapors are heavier than air and accumulate in low areas. Use only with adequate ventilation. Use appropriate respiratory protection, when ventilation is inadequate. Avoid contact with skin or eyes. Wash thoroughly after handling. When using do not eat, drink, or smoke. Poly-Tetrafluoroethylene should not be handled around tobacco products. The inhalation of vapors in the presence of tobacco products will cause polymer fume fever.

**Storage Conditions:** Store in a well-ventilated place and keep container tightly closed. Keep away from heat, sparks and flames. Do not allow stored product to exceed 52°C (125°F) to prevent leakage or potential rupture of container from pressure and expansion.
