## Hazardous warnings

Highly flammable aerosol. Causes serious eye irritation. May cause drowsiness or dizziness

### **Precautionary Statements**

Keep away from heat/sparks/open flames/hot surfaces – No smoking. Do not spray on an open flame or other ignition source. Pressurized container: Do not pierce or burn, even after use.

Avoid breathing fumes/gas/vapor/spray.

Wash skin thoroughly after handling.

Use only outdoors or in a well-ventilated area.

Wear protective gloves/eye protection/face protection.

IF ON SKIN (or hair): Remove/Take off immediately all contaminated clothing. Rinse skin with water/shower.

IF INHALED: Remove victim to fresh air and keep at rest in a position comfortable for breathing.

### 4. FIRST AID MEASURES

**Inhalation:** Remove patient to fresh air. Get medical attention.

**Eye:** Immediately flush eyes with plenty of water for at least 15 minutes. If easy to do, remove contact lenses. Continue to rinse. Get medical attention.

**Skin:** Immediately flush skin with plenty of water. Remove contaminated clothing and shoes. Wash clothing before use. Thoroughly clean shoes before reuse. Get medical attention.

**Oral:** DO NOT induce vomiting. Get medical attention. Rinse mouth thoroughly with water. Never give anything by mouth to an unconscious person.

**Most important symptoms and effects, both acute and delayed:** Eye contact may provoke the following symptoms: Irritation Causes serious eye irritation. May cause drowsiness or dizziness. Other symptoms potentially related to misuse or inhalation: Headache, drowsiness, staggering, unconsciousness.

#### 5. FIRE FIGHTING MEASURES

Flammability: This product is flammable.

Test Method: Ignition distance test and Enclosed space ignition test

**Special Fire Fighting Instruction:** Self-contained breathing apparatus (SCBA) maybe required if a large amount of aerosols rupture under fire conditions. Evacuate personnel to safe area. Fight fire from a distance, heat may rupture containers.

**Further information:** Keep containers cool by spraying with water.

#### 6. ACCIDENTAL RELEASE MEASURES

**Personal precautions, protective equipment and emergency procedures:** Flammable aerosol. Use personal protective equipment. Avoid breathing vapors, mist or gas. Evacuate personnel to safe area. Remove all sources of ignition. Ensure adequate ventilation, especially in confined areas. Wear suitable respiratory equipment.

**Environmental Precautions:** If containers rupture, prevent material from entering sewers, waterways, or low areas. Should not be released into the environment.

**Methods and material for containment and cleaning up:** Immediately notify authorities of any reportable spill as may be required pursuant to regulations. Prevent further leakage or spillage, if safe to do so. Use non-flammable absorbent and transfer the absorbent material, using non-sparking tools into an approved container for disposal according to local regulations.

## 7. HANDLING AND STORAGE

**Handling:** Avoid contact with eyes, skin, or clothing. Do not inhale vapor or mist. Wash thoroughly after handling. Keep away from heat, sparks, and open flame. Take measures to prevent the buildup of electrostatic charge.

**Storage Conditions:** Store in a clean, cool and dry area that is well-ventilated. Do not store sources of heat, in direct sunlight or where temperatures exceed 120°F/49°C. Do not pierce or burn, even after use.

## 8. EXPOSURE CONTROLS/PERSONAL PROTECTION

Use only with adequate ventilation.
