### 2. HAZARDS IDENTIFICATION

#### Hazard classification

Flammable aerosol: Category 2 Serious Eye Damage/Irritation: Category 2A. Specific Target Organ Toxicity (central nervous system): Category 3.

#### **Precautionary Statements**

Keep away from heat/sparks/open flames/hot surfaces – No smoking. Do not spray on an open flame or other ignition source. Do not pierce or burn, even after use. Avoid breathing fumes/gas/vapor/spray. Wash skin thoroughly after handling. Use only outdoors or in a well-ventilated area. Wear protective gloves/eye protection/face protection. IF INHALED: Remove person to fresh air and keep comfortable for breathing. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice/ attention. Call a POISON CENTER or doctor/physician if you feel unwell. Protect from sunlight. #### 4. FIRST AID MEASURES

**Inhalation:** Remove victim to fresh air and keep at rest in a position comfortable for breathing. Get medical attention if symptoms occur.

**Eye:** Flush with large amounts of water for at least 15 minutes, lifting eyelids until no evidence of the chemical remains. Remove contact lenses, if present and easy to do. Continue to rinse. Get medical attention.

Skin: Wash skin with water and soap as precaution. after contact. Get medical attention if symptoms occur.

**Oral:** DO NOT induce vomiting without medical advice. Rinse mouth thoroughly with water. Never give anything by mouth to an unconscious person. Get medical attention if symptoms occur.

#### 5. FIRE FIGHTING MEASURES

Flammability: This product is flammable. Test Method: Ignition distance test and Enclosed space ignition test

Suitable Extinguishing Media: Water spray, Alcohol resistant foam, Dry chemical, Carbon dioxide (CO2)

Unsuitable extinguishing media: Do not use a heavy water stream. Use of heavy stream of water may spread fire.

**Special hazards:** Vapors may form explosive mixture with air. Exposure to combustion products may be hazardous to health. Hazardous combustion products: Hydrogen fluoride, Carbon oxides.

**Special Fire Fighting Instruction:** In the event of fire, use personal protective equipment. Wear self-contained breathing apparatus, if necessary. Exposure to decomposition products may be a hazard to health.

**Further information:** Use extinguishing measures that are appropriate to local circumstances and the surrounding environment. Evacuate personnel to safe areas. # 6. ACCIDENTAL RELEASE MEASURES

**Personal precautions, protective equipment and emergency procedures:** Evacuate personnel to safe area. Use appropriate personal protection equipment.

**Environmental precautions:** Prevent material from entering sewers, waterways, or low areas. Should not be released into the environment. Retain and dispose of contaminated wash water. Local authorities should be advised if significant spillages cannot be contained.

**Spill Cleanup**: Contain spillage, and then collect with an electrically protected vacuum cleaner or by wet-brushing and put the material into a convenient waste disposal container for disposal according to local regulations.

# 7. <u>HANDLING AND STORAGE</u>

**Handling:** Avoid contact with eyes, skin, or clothing. Do not inhale vapor or mist. Wash thoroughly after handling. Keep away from heat, sparks, and open flame. Take measures to prevent the buildup of electrostatic charge. Use only in an area equipped with explosion-proof exhaust ventilation if advised by assessment of the local exposure potential.

**Storage Conditions:** Store in a clean, cool and dry area that is well-ventilated. Do not store sources of ignition or heat, in direct sunlight or where temperatures exceed 120<sup>o</sup>F/49<sup>o</sup>C. Do not pierce or burn, even after use.

**Respiratory Protection:** General and local exhaust ventilation is recommended to maintain vapor exposures below recommended limits. Possibility of hazardous reactions: Hazardous polymerization will not occur

Material and Conditions to Avoid: Heat, flames, sparks. Extreme temperatures and direct sunlight. Strong acids, Strong bases and Strong oxidizers.

**Decomposition:** This product can be decomposed by high temperatures (flame, glowing metal surfaces, etc.) forming Carbon oxides, Hydrogen fluoride, Perfluoroisobutylene (PFIB).
