2. HAZARDS IDENTIFICATION

4. FIRST AID MEASURES

Inhalation: If inhaled, remove to fresh air. Get medical attention if symptoms occur.

Eye: Flush with water as a precaution. Get medical attention if irritation develops and persists.

5. FIRE FIGHTING MEASURES

Flammability: This product is flammable. **Test Method:** Ignition distance test and Enclosed space ignition test

Suitable Extinguishing Media: Water spray, Water mist, Dry chemical, Carbon dioxide (CO2)

Unsuitable extinguishing media: High volume water jet.

Specific hazards during fire-fighting: Do not use a solid water stream as it may scatter the spread fire. Flash back possible over considerable distance. Vapors may form flammable mixture with air. Exposure to combustion products may be hazardous to health.

6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures: Remove all sources of ignition. Evacuate personnel to safe area. Use personal protective equipment.

Environmental precautions: If containers rupture, prevent material from entering sewers, waterways, or low areas. Should not be released into the environment.

Spill Cleanup: Contain spillage, and then collect with non-combustible absorbent material, (e.g. sand, earth, diatomaceous earth, vermiculite) and place in container for disposal according to local / national regulations

7. HANDLING AND STORAGE

Handling: Use in a well-ventilated area to avoid breathing vapors. Use only in an area with explosion-proof exhaust ventilation if advised by assessment of local exposure potential. Keep away from ignition sources. When using do not eat, drink, or smoke. Avoid contact with skin, eyes or clothing. Wash thoroughly after handling.

Storage Conditions: Store in a clean, cool and dry area that is well-ventilated. Do not store sources of heat, in direct sunlight or where temperatures exceed 120°F/49°C. Do not pierce or burn, even after use.

Respiratory Protection: General and local exhaust ventilation is recommended to maintain vapor exposures below recommended limits.
