#### **Description:**

Miller-Stephenson has a developed a high-performance paintable release agent specifically designed for release of complex, challenging mold designs. Our product minimizes/eliminates "fish eyes", provides high surface quality, consistent color pigmentation, and accurate replication of mold patterns. ReleaSys™ 7500 is extremely heat stable and can be used in high temperature applications up to 400°C / 752 °F. Most importantly, ReleaSys™ 7500 achieves all of this in a highly efficient and cost-effective system. Benefits Include:

#### **Recommended Application Procedure:**

- Clean mold surface thoroughly. Mechanical cleaning such as bead media blasting, followed by chemical cleaning, provides the best surface for application. Removal of all previous mold release agent and contamination is critical.
- ReleaSys<sup>™</sup> 7500 can be applied by any spray equipment that can produce fine atomization and deposit a uniform, thin film. Apply light coats, approximately 8-10 inches from the surface. Surface wiping can be done as well, no additional polishing is required.
- ReleaSys<sup>™</sup> 7500 is a concentrated product. It can be used as is for release of complex molds or diluted to a final working concentration. Dilution is ideally performed with DI water.

Note: When diluting, add DI water to the ReleaSys™ 7500 and not the inverse. Emulsion instability and product performance may be affected if this done incorrectly.

 Allow ReleaSys<sup>™</sup> 7500 to dry completely. Multiple light coats can be applied, and in some cases will increase durability and protection. Typically, 1-2 coats are sufficient.  Overapplication should be avoided. Evaluation should be performed to find the ideal application volume as well as dilution (if performed) for your given release requirements.

### Reapplication:

 When release becomes hesitant, immediately clean mold and reapply one coat of ReleaSys™ 7500 in the same manner as described previously. Spot touch-ups can also be done on known high wear or geometrically strained areas.

#### Storage and Handling:

ReleaSys™ 7500 should be stored in a well-ventilated area which is cool and dry. Do not expose to freezing temperatures. Prior to use, container should be lightly agitated.

ReleaSys<sup>™</sup> 7500 should not be used at temperatures above 400 °C or near open flames. Chemical breakdown will occur which will result in the generation of toxic fumes. When spraying, avoid inhalation of mist and exposure to skin. Always wash hands after handling. Safety Data Sheet (SDS) is available upon request.
